

# State Medicaid Coverage for Collaborative Care Management Codes

The Meadows Mental Health Policy Institute and Concert Health have co-developed a summary of Medicaid adoption of the Collaborative Care Management (CoCM) codes 99492-99494 and G2214.

## This summary includes

- Coverage status of the codes by state Medicaid agencies.
- Whether reimbursement rates are listed on the Medicaid fee schedule.
- Comparisons of Medicaid reimbursement rates to Medicare in each state.
- Any state-specific restrictions or requirements.

The information was compiled through extensive research of state Medicaid websites, policies, and publicly available guidance. While this serves as a useful guide, we recommend confirming details with the state Medicaid agency and applicable managed care organizations.
